

WHAT DOES A WARRANT LOOK LIKE?

DOES IT HAVE BASIC INFORMATION

When examining the warrant, look for your name, your address, and a signature. The warrant will be in English. If you have trouble reading it or understanding it, get someone else in your house to help you read it or translate it, if possible.

WAS IT ISSUED BY A COURT

If the warrant looks like it was issued by *Immigration and Customs Enforcement (ICE)* but not a court, the warrant is not valid. A warrant is only valid if it is issued by a court and signed by a judge.


CALL COLORADO RAPID RESPONSE NETWORK
